

**ADDENDUM TO THE ACKNOWLEDGMENT OF RISK,
WAIVER OF LIABILITY, INDEMNIFICATION, AND CONSENT**

As legal guardians of _____, we hereby acknowledge that the Acknowledgment of Risk, Waiver of Liability, Indemnification, and Consent previously executed shall remain in full force and effect, and this Addendum shall simply expand upon the risks inherent in attending, participating or visiting the premises in which Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', activities occur. The undersigned legal guardians waive further notification pursuant to the "**Notice to Guardians Provisions**," as set forth within Florida Statute, Section 744.301, which have been provided within the original Acknowledgment of Risk, Waiver of Liability, Indemnification, and Consent.

The undersigned acknowledge that novel coronavirus ("COVID-19") infections have been confirmed throughout the United States, including Florida and, in particular, the Tampa Bay community. In accordance with the most recent guidance and protocols issued by federal, state and local health agencies, for slowing the transmission of COVID-19, the undersigned hereby agree, represent and warrant that neither the undersigned, nor such participating minor, shall visit or utilize the facilities, services, and programs of Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', within 14 days after:

- (1) Returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice;
- (2) Exposure to any person returning from areas subject to a CDC Level 3 Travel Health Notice; or
- (3) Exposure to any person who has had a suspected or confirmed case of COVID-19.

The CDC Travel Health Network is continuously updating this list, and the undersigned agree that they are aware of this list and acknowledge their obligation to check the CDC Travel Health notice list prior to utilizing the facilities, in the event their individual factors warrant same.

The undersigned further agree, represent and warrant that neither the undersigned, nor any such participating minor, shall visit or utilize the facilities, services and/or programs of Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', if he or she:

- (1) Experience symptoms of COVID-19, including without limitation, fever, cough or shortness of breath; or
- (2) Have a suspected or diagnosed/confirmed case of COVID-19.

The undersigned agree to notify Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', immediately, if they believe that any of the foregoing access/use restrictions may apply, for purposes of providing contact data necessary to limit the further exposure of others to the COVID-19 virus.

Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', have taken certain steps to implement recommended guidance and protocols issued by the applicable

federal, state and local health agencies for slowing the transmission of COVID-19, including without limitation, the access/use restrictions as set forth above.

The undersigned further acknowledge and agree that, due to the nature of the facilities, services and programs offered by Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', social distancing of six feet per person, among the minors and their coaches, volunteers and/or instructors, may not be possible.

The undersigned fully understand and appreciate both the known and potential dangers of utilizing the facilities, services and programs of Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', and acknowledge that this unprecedented COVID-19 pandemic shall constitute an inherent risk when utilizing the facilities, services and programs of Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', despite Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin's, reasonable efforts to mitigate such dangers, which may result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability and/or death, for which the undersigned, pursuant to the Acknowledgment of Risk, Waiver of Liability, Indemnification, and Consent agree to hold Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', harmless and, therefore, release said entities, their employees, instructors, coaches, agents, and any and all other volunteers, from any and all liability for any injury suffered while under the instruction, supervision, or control, direct or indirect, of Florida Top Dog All-Stars, Inc. and/or Terrick Training, Inc., d/b/a Just Tumblin', its employees, instructors, coaches, agents, and any and all other volunteers, whether caused by their own negligence or otherwise.

The undersigned expressly agree that this Addendum to the Acknowledgment of Risk, Waiver of Liability, Indemnification, and Consent is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that if any portion of this document is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned further acknowledge that they are authorized to execute this Addendum to the Acknowledgment of Risk, Waiver of Liability, Indemnification, and Consent on behalf of the participant and the parents, guardian, legal representative, personal representative, assigns, heirs, and next of kin.
