I, the Undersigned, voluntarily enter into this WAIVER OF LIABILITY AND GENERAL RELEASE (the "Waiver"), and do waive and release, assume all risks, and agree to indemnify and hold harmless LWRC, its directors, officers, employees, agents, representatives, related entities, owners, successors, and the assignees of LWRC from and against any and all claims for death, personal injuries, workers' compensation, loss of property, property damage, and actions of any kind whatsoever, arising directly or indirectly out of or related to My use of or interaction with LWRC, LWRC Facilities and LWRC Property, or arising out of or related to My participation in or observation of LWRC Activities, including without limitation, liability arising out of any negligence, carelessness, action, omission, or conduct on the part of the LWRC.

**LWRC PROPERTY, FACILITIES, AND EQUIPMENT**

I understand, acknowledge, and agree that I am not authorized to use any LWRC Facility or LWRC Property, unless I have been so advised and permitted by LWRC, and have been advised sufficiently as to where I am and am not authorized to be. I also agree to comply with any verbal direction or instructions provided by LWRC as to such authorization, access, use, interaction, or observation.

Notwithstanding the aforementioned limitations, I understand and acknowledge that I may be asked to be an observer or limited participant within an area containing LWRC Property or a LWRC Facility which I am not permitted to use, but nevertheless may have need to be at or near, walk or stand on, touch, or interact with in order to comply with LWRC policies and procedures. I understand and acknowledge I am entirely voluntarily coming into contact with such property, equipment, or facility at My own risk. I further understand that LWRC is not and shall not be responsible for any injury that may occur due to My use or interaction with of the LWRC Facilities and LWRC Property. I further represent and warrant that I have sufficient health insurance to cover any and all injuries that I may sustain through use of or interaction with the LWRC Facilities or LWRC Property. I agree to be solely responsible for all such injuries, damages, loss, medical treatment, bills or otherwise that results from My use of or interaction with the LWRC Facilities and LWRC Property.

I acknowledge that I will use the LWRC Facilities and LWRC Property with reasonable and extraordinary care and take all precautions to minimize injury to Myself and others. I understand that it is My responsibility to immediately report any injury occurring as a result of the use of or interaction with the LWRC Facilities and LWRC Property to the LWRC. I shall also immediately report any problem, issue or dangerous condition existing or suspected of existing at the LWRC Facilities and LWRC Property. I acknowledge the availability of instructions on the proper use of all LWRC Property and LWRC Facilities and represent that I will either read such instructions or get instruction from a qualified person prior to My use of or interaction with any LWRC Facility or LWRC Property. I shall only use or interact with such that I have complete understanding of its proper use, safety features, potential hazards, and warnings. I will not use any LWRC Facility or LWRC Property that I am not familiar with or that appears to be in disrepair. I further acknowledge that I understand all of the risks associated with use of the LWRC Facilities and LWRC Property and that I have received or been offered a copy of this Waiver and General Release. The use of the LWRC Facilities and LWRC Property and any and all equipment located therein is at My own risk and without liability to LWRC.
